Title of the Program: INTERNATIONAL WEBINAR ON “INTELLECTUAL PROPERTY RIGHTS”

The IQAC of Sarojini Naidu College for Women, Dum Dum Kolkata organized a One Day International Webinar on “Intellectual Property Rights” on 30th August, 2020 via Google Meet platform. The event was live streamed on the college’s official YouTube channel for the audience.

Objective: The objective of the webinar was to generate an awareness of the rights, laws and applications related to intellectual property, particularly as bearers/ propagators of knowledge, in order to keep pace with the demands of the times since the way innovation as a tool is used has also undergone extensive transformation in recent times.

Content: The event was inaugurated by our respected principal madam- Dr. Urmila Ukil. Our chief guest was Prof. Basab Chaudhuri, Vice Chancellor, West Bengal State University. Our eminent speakers for the two technical sessions were Dr. Sanjib Chaudhuri, ex Chief Scientific Officer, IPR & IR, Indian Institute of Technology, Kharagpur and Dr. Kaberi Datta, Registered Patent Agent and Assistant Professor, Department of Zoology, Sarojini Naidu College for Women, Kolkata.

The event saw 250 registered participants from colleges across West Bengal as well as other states of India including but not limited to Odisha, Telengana, Delhi, Tamil Nadu, Uttar Pradesh, Bihar, and Assam. Participants ranged from college and university faculty, private educational institute faculty, research scholars, and students.

During the first technical session, Dr. Sanjib Chaudhuri informed the audience about innovation as a tool in economic and societal development as well as a mode of individual financial security, its history and the rise of various laws governing the use of such innovation as tangible property, the introduction to patents, their role in economy, their use and benefit in research and industry.

During the second technical session, Dr. Kaberi Datta talked about the process of patenting research inventions in India, the pitfalls to avoid during patenting and the criteria to be met for the award of patents; the territorial nature of patents and the process for international patenting. She gave a comprehensive idea about copyright in science and education, how and when such rights are to be used by those in academia, plagiarism in publication and trademarks and ways to safeguard against such malpractices.

Outcome: The cumulative outcome of all the technical sessions was that the audience was apprised about the state of the art of knowledge economy and its basic limbs of intellectual property and research. The various ways in which the audience can avail themselves of the benefits of the monopoly provided by IPR was explained. From the feedback responses of the participants it is anticipated that the technical sessions of the event proved fruitful for them and enhanced their knowledge on the concerned subject.
